After the fourteen (14) day cooling off period, provided you have not made a claim, you will be entitled to a refund of any premium paid, subject toa deduction for any time for which you have been covered and the administrative cost of providing the insurance.		
-	If you want to cancel after this period you may be entitled to a refund but not if a claim has been made orthere has been an incident which may give rise to a claim.
